Ladies and Gentlemen,

I am pleased to finally have the opportunity to pay an official visit to Ukraine, and to support Czech companies in this enormously perspective, although often challenging area.

Ukraine is closer to us than many Czechs might realize, both geographically and economically. Fortunately, the figures have reflected these natural ties – our mutual trade exchange has been growing fast since the inevitable decline in 2015, reaching the all-time highest turnover of 2.3 billion EUR in 2018.

Considering all hardships Ukraine is facing, the performance of its economy is remarkable. Recently, the World Bank has upgraded the forecast of GDP growth to 3.7 % in 2020. Ukrainians have made admirable progress in reforming the country and moving closer to the EU, and I believe that now is the time to appreciate newly arising opportunities in traditional fields such as energy sector, transportation and infrastructure, defense industry, or environment and agriculture. Of course, some obstacles remain, and we are helping our companies wherever possible – for this purpose, the Intergovernmental Commission has become an invaluable platform.

I carry a message of our unwavering support to the territorial integrity and sovereignty of Ukraine. Stability and security are absolutely needed for thriving business environment, and I wish it also for the sake of you and your local partners.

Dear Business Friends, Ladies and Gentlemen,

Ukraine has always been, and still is, an important and traditional business and economic partner of the Czech Republic. In the past, we were facing a complicated international political situation, which also seriously affected Czech business in Ukraine. However, after two years of a heavy decrease in mutual trade, a turn occurred in 2016, when a massive revival of economic cooperation could be observed. In 2018, the favourable development of the trade turnover continued, growing at a rate of more than 18 per cent in comparison with the previous year and reaching EUR 2.3 billion. A high growth rate was especially shown by Czech exports, with the upward trend also continuing in 2019, when the mutual trade turnover between January and August showed a 7.1 per cent growth. Of great importance for the promotion of trade and economic relations is the assistance of the Intergovernmental Commission for Economic, Industrial, Scientific and Technical Cooperation, of which I am Co-Chairman.

The macro-economic situation in Ukraine is getting stabilised. This is obviously the result of the substantial reforms carried out by the Ukrainian state administration and the fact that Ukraine is implementing the Deep and Comprehensive Free Trade Agreement (DCFTA) with the European Union in the framework of the Association Agreement with the European Union. Mutual cooperation is also supported by the visa liberalisation between the EU and Ukraine.

I am persuaded that our business mission will contribute significantly to the development of trade-economic relations between the Czech Republic and the Republic of Ukraine. I wish the participants in the mission the best of success in their negotiations and their future business activities.

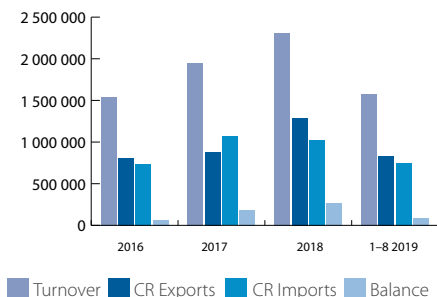

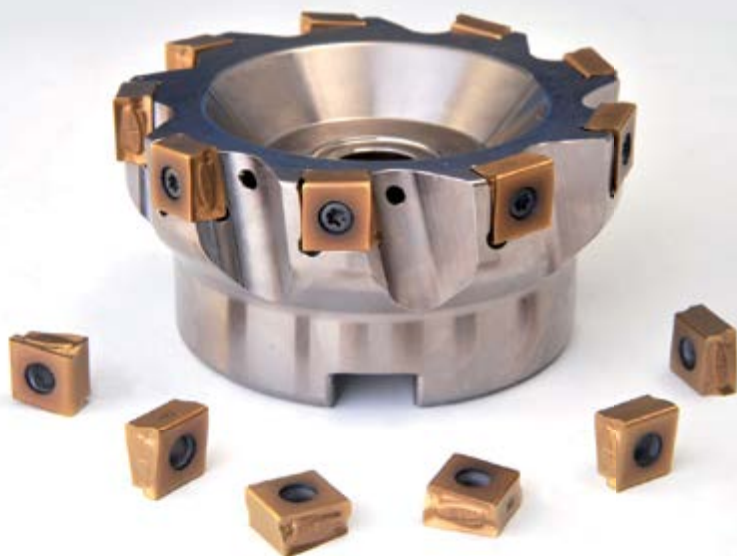
